



NOMINATIONS FOR ELECTION CAMPDRAFT MEMBERS REPRESENTATIVE COUNCIL (MRC)

The Campdraft Members Representative Council consists of eight (8) members elected to serve a two year term. Only four (4) positions become vacant each year to allow for continuity within the group.

1. Current MRC members **Paul McLennan, Stephen Wells, Glen Peterson, and Wayne Edwards** will complete their two year term as members of the MRC effective at the AGM 2019. These members are eligible for nomination and re-election if successful.
2. Full Financial Members are entitled to nominate for the four (4) vacant positions. The newly elected members of the Campdraft MRC will serve a two year term commencing the 26th July 2019.
3. Current MRC members **Lachie Maxwell, Ben McNaughton, Kathy DeJong, Jack Gallagher** will remain for a further twelve (12) month period. These four (4) members of the MRC will **not** be required to stand for re-election in 2019 and will have to re-nominate for election in 2020.
4. For a nomination to be accepted it must be made using this form only. Nominations close on Friday 17th May, 2019 at the ABCRA office not later than 5pm.
5. It is recommended that all nominees send the following;
 - a) a colour portrait photo attached which is suitable for publication.
 - b) a biography containing one hundred and fifty (150) words (approximately) outlining experience, goals and objectives. Email files will be accepted separately up until the close of nominations.
6. Valid nominations received by the closing date will be listed on a voting paper which will be distributed with the June 2019 issue of the Australian Bushmen's Campdraft & Rodeo magazine. Should there be four (4) or less nominations, there will be no requirement for a ballot.
7. Full Financial Members may nominate one or more Full Financial Members for a position on the Campdraft MRC. A Full Financial Member may also nominate on their own behalf.

All nominees and their proposer must be Full Financial Members of the Association at the time of nomination. Any nominated member or proposer un-financial at the time of nomination will render the nomination invalid.

9. Attend meetings throughout the year.
10. Work in conjunction with committees and directors to ensure suitable arena conditions
